I am writing to you in relation to document a) mentioned above to submit, within the period stipulated by law, the information requested pursuant to the request made by Mr. Rafael Ortiz Encalada in document b), as follows:

- 1. In relation to point one of document b) mentioned above, attached hereto is Table. No. 2 of Court Judgments having *res judicata* status Group 5 (Law No. 30137 Supreme Decree No. 001-2014-JUS), containing all of the Land Debts that, to date, have been paid over the course of 2015, showing outstanding balances in the column titled "balance payable," as approved by the Committee responsible for preparing and approving the Prioritized List of Obligations Derived from Judgments having *res judicata* status pursuant to Law No. 30137.
- With respect to point two of document b) mentioned above, the response to the request is detailed in the aforementioned table attached hereto, which contains all of the court proceedings filed against the Ministry of Agriculture and Irrigation involving Land Debt. We do not have information regarding the list of court proceedings involving Land Debt filed by claimants against the Ministry of Economy and Finance.

Likewise, we specify that the information in the aforementioned table contains all court cases that, with regard to land debt, have ended with a judgment of *res judicata* and with expert testimony approved for a final decision, also showing the names of the claimants.

It is important to bear in mind that it is the will and decision of the current ministerial leadership to proceed to deal with all court obligations within the constraints and fiscal balance established by law and that, in the present year 2015, as in the 2014 fiscal year, no specific budget item was allocated to the Ministry of Agriculture and Irrigation to meet court obligations derived from Land Reform. Therefore, the legal authority to allocate up to three percent (3%) of the Preliminary Institutional Budget (PIA) was exercised to satisfy the debts derived from court judgments having the force of *res judicata* to deal with this financial obligation, an internal budgetary effort made possible after rationalizing budgetary requirements and expenses from its different areas and units, thereby revealing its intention to meet said obligations within its budgetary constraints, showing that for the outstanding balances it has made and continues to requisition budgetary allocations from the Ministry of Economy and Finance, for the approval of a supplemental loan to make it possible to pay off unpaid court debts not incurred by the Ministry of Agriculture and Irrigation *per se*, but rather by the Government as a whole, prior to the Land Reform. To this end it could gain

approval of the necessary budget items from the Ministry of Economy and Finance or by providing them to the Ministry of Agriculture and Irrigation; this latter mechanism, unfortunately, was not accepted, either in the mode of additional budgetary funds or as supplemental loans, which is why <u>the only budget item available to the Ministry of Agriculture and Irrigation is that created pursuant to Art. 70 of Law 28411, as amended by the Fifth Supplemental Amending Provision of Law 29626, the amount of which clearly does not suffice to cover payment in full of the obligations generated by Land Reform Act No. 17716.</u>

It should be said that, in view of the new regime for prioritizing debts, during the 2014 fiscal year, the budget item generated by the 3% of the Ministry of Agriculture and Irrigation's Preliminary Institutional Budget (PIA) was fully spent in the labor and benefits categories, with the same prioritization stipulated by Law No. 30137 given this fiscal year, that being 2015.

Thus, one must bear in mind that the Ministry of Agriculture and Irrigation intends to pay in all court proceedings, considering the limited budgetary resources that, by law, it may use for this purpose, rationalizing its ordinary resources, since, as indicated above, no specific budget item has been approved to cover the land debt. Therefore, as one can see in Table No. 2 attached hereto, judgments having *res judicata* status have been paid according to the order of priority made by the Standing Committee responsible for preparing and approving the prioritized list of payment for court judgments referred to in Law No. 30137 and its corresponding Regulations, it being necessary to consider that, with respect to outstanding balances, it will continue to insist that it be allocated budgetary resources to meet these obligations even when, in relation to previous requisitions made, the Ministry of Economy and Finance has indicated that they cannot be met, with the recommendation that payment proceed with the 3% of the Ministry's PIA, a response that may change in the event that the judicial request for payment of outstanding balances is sent to the government body that legally has the authority to administer the Public Treasury, authority that clearly does not reside with the Ministry of Agriculture and Irrigation.
